





Speaker Bio

Robert A. Werth holds a degree in International Commercial Arbitration issued from the Chartered Institute of Arbitrators and is Fellow of the Institute; is Dipl.-Ing for Civil Engineering and Construction, is appointed on the FIDIC President's List of Approved Dispute Adjudicators and panelist of other institutions. Robert is publicly appointed and sworn as Expert for quantum and FIDIC conditions.

In the first part of his professional career, he was Principal Engineer and in management responsible for large and extra-large infrastructure projects before becoming a full-time Dispute Resolution Practitioner. Since then, he has served as an Arbitrator, Adjudicator or Dispute Board Member on International Contracts, frequently also as Expert Witness.

Robert has been appointed by the following competent appointing bodies; the ICC, the President of FIDIC, LCIA, the German Arbitration Institute, KfW, the Addis Ababa Chamber of Commerce and Sectoral Association and the Georgian Chamber of Commerce and Industry. Robert was appointed by his National Committee (ICC Germany) as a Delegate to the ICC Commission on Arbitration and ADR (the 'Commission') from 2020 to 2024.
